Members considered the quotations put forward for the ground's contracts. After careful consideration it was decided to award the contracts to Garden Designs and GHT Ltd. Members agreed a 3-year term with an option to extend by another 3 years if mutually acceptable. It was accepted that fees would rise in line with the inflation figure each year and a negotiation would take place each year to confirm the rate. Proposed by Cllr. Jones, seconded by Cllr. Boresjo with all members in favour.
