Members voted 5 votes to 3 to raise the cemetery fees by 5% from the 1st April 2022. Proposed by Cllr. Bennett and seconded by Cllr. Beer.

Members were informed that the company who did the grass cutting in the recreation ground and behind the Memorial Hall had put their prices up significantly. The Clerk was able to get a second quote but it was too late to go onto the agenda. They decided to go the alternative supplier moving on. All members were in favour.
