Members had an **OBJECTION** to this application. Members felt it was:

- The application is believed to not comply with **OW8 Townscape** of the Old Windsor Neighbourhood Plan
- And also OW9 Heritage Assets
- Overbearing on the site in terms of size.
- There would be a negative impact on neighbours due to scale, noise from visitors and, potentially, vandalism that it would likely attract.
- The design looks very unstable as a long term structure and there are concerns about what forward maintenance would be used to maintain it.
- There are concerns about using the land in this way as it offers no permanence.

In the Access, Design & Heritage Statement it states "There is currently no war memorial in Old Windsor" which is completely incorrect as the Old Windsor Memorial Hall has a war memorial in the front, the Parish Church has a war memorial as does Beaumont. War Memorials are usually placed in community or church ground to ensure access and permanence whereas this land appears to be owned by a commercial body.
