111.23 MATTERS ARISING FROM THE ABOVE MINUTES

Cllr. Beer requested that a better explanation of Cllr. Ewan Larcombe's visit be given. Cllr. Larcombe asked if OWPC would meet with Datchet, Horton and Wraysbury to discuss joint action on flooding and also to oppose the EA's proposal at it's Regional Council to increase its funding on the River Thames Scheme as it has been slow in showing much progress on this over the recent years. As this was likely to be counter productive there was no support for that proposal. It was also pointed out that the date of the next meeting was incorrect.
